*Subject : Grant of dearness relief to Assam Government pensioners/family pensioners/extra-ordinary pension holders with effect from 01-07-2019.*

In continuation to this office circular No. Pen. Co-ordn./Assam/Vol.-VIII/DR/29 dated 10-05-2019, this is to state that the Government of Assam in their O.M. No. FEG.08/2017/60 dated 23-10-2019 have sanctioned dearness relief to their pensioners/family pensioners/extra-ordinary pension holders as under :

<i>Date of effect</i>	<i>Rate of dearness relief per month</i>
01-07-2019	17% of basic pension/family pension

2. The payment on account of dearness relief involving fraction of 50 paise and above may be rounded off to the next higher rupee and fraction of less than 50 paise may be ignored.

3. Having been authorized by the Principal Accountant General (A&E), Assam in their letter No. GE-1/State/DA/2019-20/3288 dated 18-11-2019, it is requested to make necessary arrangement for payment of dearness relief @ 17% to all eligible Assam Government pensioners/family pensioners/extra-ordinary pension holders with effect from 01-07-2019 after proper adjustment.
