Co-ordn./Odisha/Vol.- VI/Rev-Judi/252 dated 24-03-2015, this is to state that the Government of Odisha in their Resolution No. VJ-53/2019/8881/L dated 30-08-2019 has modified para 5(a) of their Resolution No. 28715/F dated 09-10-2014 (para 1 of circular dated 24-03-2015 ibid) as under:

"Para 5(a) – The pension of Judicial Officers who retired/died prior to 01-01-2006 but after 01-01-1996 including the Judicial Officers whose pension were consolidated as per Karnatak model shall be raised by 3.07 times at par with the other pensioners subject to minimum of the 50% of the revised pay scales of pay of their respective posts."
