Subject: Grant of Dearness Relief to the Punjab Government pensioners/family pensioners/extra ordinary pensioners with effect from 01-11-2019.

In continuation to this office circular No. Pen. Co-ordn./Punjab/Vol.- VI/DR/63 dated 18-07-2019, this is to state that the Government of Punjab in their circular letter Nos. 7/44/2015-1FP1/1599531/1 dated 21-10-2019 has sanctioned dearness relief to their pensioners/family pensioners/extra ordinary pensioners at the rate and from the date as under:

Date of effect Rate of dearness relief per month
01-11-2019 142% of basic pension/family pension

2. Circular for release of arrears of 3% dearness relief from 01-01-2018 will be issued on receipt of authority in this regard from the o/o the Accountant General (A&E), Punjab.

3. Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee if the same is 50 paise or above. Conversely, it will be rounded off to the lower side if the same is less than 50 paise.

4. Other provisions governing grant of dearness relief to pensioners/family pensioners such as regulation of dearness relief during employment/re-employment and regulation of

dearness relief where more than one pension is drawn etc. will remain unchanged.

5. Having been authorised by the Accountant General (A&E), Punjab in their letter No. PEN-12/Imp. Order/DA/SSA NO. /2019-20/4046 – 80 dated 10-01-2020, it is requested to make necessary arrangement for payment of dearness relief @ 142% to all eligible Punjab Government pensioners/family pensioners/extra ordinary pensioners with effect from 01-11-2019 after proper adjustment.
