Subject : Grant of Dearness Relief to the Goa Government pensioners/family pensioners on their un-revised pension/family pension with effect from 01-01-2019 and 01-07-2019.

In continuation to this office circular No. Pen. Co-ordn./Goa/Vol.-V/DR/82 dated 27-08-2019, this is to state that the Government of Goa in their Order No. 12/1/2019-Fin (R&C) dated 11-02-2019 has sanctioned dearness relief to the pensioners/family pensioners of Goa Government and its Autonomous Bodies who are in receipt of pension/family pension in pre-revised pay structure/scales of Sixth Central Pay Commission, at the rate and from the date as under :

<i>Date of effect</i>	<i>Rate of Dearness relief per month</i>
01-01-2019	154% of basic pension/family pension
01-07-2019	164% of basic pension/family pension

2) This relief is not admissible to the pensioners drawing pension which is granted after independence for political consideration (Ex-Rulers); Retired High Court and Supreme Court Judges for whom order will be issued separately by administrative authorities concerned; and pensioners of other states (PAO Suspense) for whom separate orders are applicable; MLA and Freedom Fighters of Government of Goa.

3) Having been authorized by the Directorate of Accounts, Government of Goa in their letter No. DA/PA-I/Pens/19-20/TR-1026/DR-340 dated 27-01-2020, it is requested to make necessary arrangement for payment of dearness relief to all eligible Goa Government pensioners/family pensioners mentioned above @ 154% and 164% on their basic pension/family pension with effect from 01-01-2019 and 01-07-2019 respectively after proper adjustment.

5) The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Goa etc."
