Subject : Grant of dearness relief to the Goa Government Freedom Fighter pensioners/family pensioners with effect from 01-07-2019.

In continuation to this office circular No. Pen. Co-ordn./Goa/Vol.-V/DR-FF/164 dated 24-01-2020, this is to state that the Government of Goa in their FD Order No. 11/4/2012-HD(G)/17 dated 01-01-2020 have adopted the rate of dearness relief announced by the Central Government in respect of their Freedom Fighter pensioners/family pensioners, as under :

Date of effect	Rate of dearness relief per month
01-07-2019	164% of basic pension/family pension

2. Payment of dearness involving a fraction of a rupee shall be rounded off to the next higher rupee.

3. Having been authorised by the Director of Accounts, Government of Goa in their letter No. DA/PA-I/Pens/19-20/TR-1036/DR-366 dated 12-02-2020, it is requested to make necessary arrangement for payment of dearness relief on pension/family pension to the Goa Government Freedom Fighter pensioners/family pensioners @ 164% with effect from 01-07-2019 after proper adjustment.
