Sub: Constitution of A&E (Assam) Placement Board for implementation of the Hon'ble Supreme Court's judgment dated October 31, 2013, in WP (Civil) No. 82/2011

In implementation of the Hon'ble Supreme Court's judgment dated October 31, 2013, in WP (Civil) No. 82/2011 in the matter of Sri TSR Subramanium & Ors. Vs. Union of India & Ors, the Competent Authority has decided to constitute A&E (Assam) Placement Boards (hereafter APB) to make recommendations on Transfer & Posting at various levels.

2. Accordingly, structures of the APBs will be as follows:

LEVEL - I (Gazetted Group 'B')

- a. Principal Accountant General/Accountant General (A&E) Accepting Authority
- b. Sr. DAG/DAG (Accounts & VLC) Member*
- c. Sr. DAG/DAG (Admn.) Member*
- d. Asstt. Accountant General/Sr. Accounts Officer/Accounts Officer (Admn.) Member.

LEVEL – II (All non-gazetted)

- a. Sr. DAG/DAG (Admn.) Accepting Authority
- Asstt. Accountant General/Sr. Accounts Officer/Accounts Officer (ITA) Member*
- c. Asstt. Accountant General/Sr. Accounts Officer/Accounts Officer (Admn.) Member*
- d. Asstt. Accountant General/Sr. Accounts Officer/Accounts Officer (TMC) Member*

*The senior most Member would be the Chairperson of APB.

3. The APBs, as notified above, would be a recommendatory body and their recommendations will be placed before the Competent Authority for final orders, as per existing rules. The APBs shall make recommendations for transfers among the three functional wings of this Office, viz. Accounts, Entitlements & Administration. The Pr. Accountant General/Accountant General (A&E) shall have the authority to

extend/shorten the minimum prescribed tenure of two years at his/her discretion and his/her decision upon the recommendations of the Board shall be final.

- 4. It has also been decided to keep a minimum tenure of two years in a functional wing for all Group 'B' and 'C' personnel, except for the following eight categories of personnel/wing/section/post:
 - I. New Recruits.
 - II. Personnel on deputation from other Offices/Departments.
 - III. Sensitive wings/sections/posts.
 - IV. All Multi-tasked employees (excluding Selection Grade Record Keepers).
 - V. Sr. Private Secretary, Sr. Personal Assistant, Personal Assistants and Stenographers of all Group 'A' Officers.
 - VI. Rajbhasha Adhikari, Baristha Rajbhasha Anuvadak, Kanistha Rajbhasha Anuvadak and Rajbhasha Tankak.
 - VII. Welfare Assistant, Staff Car Driver, Asstt. Caretaker, Cashier and Asstt. Cashier.
 - VIII. All personnel borne on ex-cadre posts.
- 5. The transfer of any Group 'B' and/or Group 'C' personnel before completion of the minimum tenure may be done in the public interest only after considering and recording reasons for the same by the concerned APB, as the case may be, before making their recommendations.

6. These orders shall take effect from January 31st, 2014.
