Subject : Grant of Dearness Relief to the Retired Judicial Officers / family pensioners of the State of West Bengal - revised rate effective from 01/01/2019.

Sir,

The Government of West Bengal, Judicial Department under their letter No. 1199-J/JD/V/2A-14/17 dated 12/03/2019, has communicated that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category has been **enhanced from 148% to 154% with effect from 01/01/2019.**

Accordingly, in continuation to this office circular No. Pen. Co-ordn./65 Vol.IV/148 dated 31/10/2018 read with No. Pen Co-ordn./65 Vol.IV/171 dated 26/11/2018 , all concerned Pension Disbursing Authorities are requested to make necessary arrangement for payment of Dearness Relief @ **154%** to the above category of pensioners / family pensioners with effect from 01/01/2019 after proper adjustments of payment already made.

Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

Charges for payment are debitable to the Govt. of West Bengal, under head 2071 – Pension and other Retirement Benefits – 01 – Civil – 101 Superannuation and Retirement allowances etc.
