Sub : Status Report on Reconciliation of Departmental figures with those booked in A.G.'s office for the quarter ended 30th September, 2019.

Sir,

In inviting a reference to this Office letter No. TMC/3-3/VERFN/2019-20/802 dated 29/01/2020 on the subject cited above, I am to state that, for the quarter ended 30th September, 2019, out of 54 Chief Controlling Officers, 3 (Three) CCOs have carried out full reconciliation, 25 (Twenty Five) CCOs have carried out Partial reconciliation and 26 (Twenty Six) CCOs has carried out No reconciliation of departmental figures in both receipt and expenditure with those booked in the A.G's office. On the Expenditure side 9 (Nine) CCOs have carried out reconciliation of expenditure fully, 19 (Nineteen) CCOs have carried out reconciliation of expenditure partially and 26 (Twenty) CCOs have not at all reconciled the departmental expenditure figures. On the Receipt side, 4 (Four) CCOs have reconciled the receipt figures fully and no other CCO have carried out reconciliation of the departmental receipt figures. A detailed list showing the position of reconciliation is enclosed herewith, in ANNEXURE-I, for ready reference.

2. From the position explained above, it may be seen that most of the CCOs have not taken up the issue of reconciliation in full earnest. The Government is, therefore, requested to issue necessary instructions/orders to all the Chief Controlling Officers to carry out the reconciliation work for the quarter ended December, 2019 (FY 2019-20), to ensure cent percent reconciliation and correctness of the accounts prepared by this office.
