OFFICE ORDER

Subject:- Central Civil Services (conduct) Rules 1964 – Constitution of Committee for redressal of complaints of sexual harassment of working women.

In supersession of the office order No.Pr.AG(G&SSA)/Admn I/A10/2014-15/103 dated 04.08.2014 and in terms of Rule 3-C of CCS (conduct) Rules 1964, the Principal Accountant General (G&SSA), Principal Director of Audit (Central) and Accountant General (ERSA) have constituted the complaints committee for the redressal of complaints regarding sexual harassment of working women with immediate effect.

The composition of the committee is as follows:-

1. Smt Kamalavalli S, Sr. Deputy Accountant General (ES-II), Office of the Accountant General (ERSA) – Chairperson.
2. Welfare Officer or Audit Officer/Senior Audit Officer (HK) in the absence of Welfare Officer as Member Secretary.
3. Audit Officer/Senior Audit Officer (Admn.)/G&SSA – Member.
4. Smt V.V. Parvathi N Rao, Senior Audit Officer – Women Member.
5. Smt V. Sujatha, Audit Officer – Women Member.
6. Smt Lalitha Shastry – Women Member from Souharda Counselling & Referral Systems (N.G.O).


The committee will submit monthly report giving details of complaints redressal during the month and pending cases with reasons to Principal Accountant General (G&SSA), Principal Director of Audit (Central) and Accountant General (ERSA). If there is no complaint a “NIL” report need be submitted. Such complaints involving sexual harassment to working women may be addressed to the Chairperson of the committee and a copy of the same should be addressed to Deputy Accountant General (Admn.)/G&SSA. This committee will examine all the complaints made by the victims in the light of Supreme Court judgement in the case of Vishaka V/s State of Rajasthan & OM issued in this behalf.
