

ALLOCATION OF STATE/OFFICE TO THE CANDIDATES NOMINATED FOR APPOINTMENT TO THE POST OF ASSISTANT AUDIT OFFICER THROUGH COMBINED GRADUATE LEVEL EXAMINATION-2016 IN INDIAN AUDIT & ACCOUNTS DEPARTMENT

The Staff Selection Commission had nominated 1000 (UR-505, OBC-270, SC-150, ST-75) candidates for appointment to the post of Assistant Audit Officer through Combined Graduate Level Examination-2016.

2. The allocation of the States/Offices to the candidates has been done on the basis of Merit cum State preference submitted by the candidates online. The candidates who have not submitted online information have been allocated the States/offices under the 'General Pool' vacancies.

3. The allocation of State/office to a candidate is final and no request for change in allocation shall be entertained.

5. CAT, Prinicpal Bench, New Delhi in OA No. 2964/2017 filed by Shri Rohit Kumar and Ors/any other litigation (OAs/WPs/SLPs), as the case may be.
