

**Allocation of State/office to the candidates nominated for appointment to the post of Junior Translator through Junior Hindi Translator, Junior Translator, Senior Hindi Translator and Hindi Pradhyapak Examination, 2018 in Indian Audit & Accounts Department (IA&AD)**
