G. S. R. 551.—In exercise of the powers conferred by clause (5) of article 148 of the Constitution and after consultation with the Comptroller and Auditor General of India, the President hereby makes the following rules to amend the Indian Audit and Accounts Department, Supervisor (Accounts) Recruitment Rules, 1986 namely :—

1. (1) These rules may be called the Indian Audit and Accounts Department, Supervisor (Accounts) Recruitment (Amendment) Rules, 2001.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. For the schedule to the Indian Audit and Accounts Department Supervisor (Accounts) Recruitment Rules, 1986, following shall be substituted, namely :—

By promotion failing which by deputation.	<p>Promotion : Senior Accountants with three years regular service in the Grade.</p> <p>Note : Where juniors who have completed their qualifying/eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than half of such qualifying/eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade alongwith their juniors who have already completed such qualifying/eligibility service.</p> <p>Deputation: Officers from other Accounts and Entitlement offices in Indian Audit and Accounts Department :</p> <p>(i) holding analogous posts on regular basis; or (ii) holding the posts of Senior Accountant in the scale of Rs. 5000—8000 with three years regular service in the grade.</p> <p>The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, Deputationists shall not be eligible for consideration for appointment by promotion.</p> <p>(Period of deputation including period of deputation in another Ex-cadre post held immediately preceding this appointment in the same or some other organisation/ Department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications).</p> <p>Note : As the cadre of Supervisor (Accounts) and the feeder cadre of Senior Accountant are not centralised for the entire Department these rules shall be applicable to each cadre in various Accounts and Entitlement offices of the Department.</p>
